WHEREAS, Division 3, Northwest Hernando County, Chapter 12, Hernando County Code of Ordinances was enacted September 25, 1984 as Ordinance 84-15, and;

WHEREAS, Division 5, Weeki Wachee Acres Municipal, Chapter 12, Hernando County Code of Ordinances was enacted December 21, 1982 as Ordinance 82-16, and;

WHEREAS, Division 6, East Hernando County, Chapter 12, Hernando County Code of Ordinances was enacted December 2, 1997 as Ordinance 97-27, and;

WHEREAS, Division 7, Hernando Fire Tax District, Chapter 12, Hernando County Code of Ordinances was enacted August 27, 1991 as Ordinance 91-28, and;

WHEREAS, Division 10, Northeast Hernando County, Chapter 12, Hernando County Code of Ordinances was enacted December 19, 1991 as Ordinance 97-27, and amended on August 15, 1995 by Ordinance 95-11, and;

WHEREAS, Division 12, Central Hernando County, Chapter 12, Hernando County Code of Ordinances was enacted December 17, 2002 as Ordinance 02-25, and;

WHEREAS, Division 13, Hernando County Airport/Industrial Park, Chapter 12, Hernando County Code of Ordinances was enacted March 19, 1996 as Ordinance 96-05, and;

WHEREAS, on July 6, 1999 the Board passed Ordinance 99-11 for the intended purpose of unifying the various fire protection districts and providing for a uniform method of assessment for fire rescue services in the unincorporated portions of the County, and;

WHEREAS, the functions of Division 3, Division 5, Division 6, Division 7, Division 10, Division 12 and Division 13 of the Hernando County Code of Ordinances are currently accomplished by Article V, Chapter 12,

NOW THEREFORE, BE IT ORDAINED, by the Board of County Commissioners of Hernando County, Florida, as follows:

Section 1. Repeal

The following sections of the Hernando County Code of Ordinances are repealed: 12-91, 12-92, 12-93, 12-94, 12-96, 12-97, 12-100, 12-101, 12-102, 12-103, 12-104, 12-105, 12-106, 12-107, 12-141, 12-142, 12-143, 12-144, 12-145, 12-151, 12-152, 12-153, 12-154, 12-155, 12-156, 12-157, 12-158, 12-159, 12-160, 12-161, 12-162, 12-163, 12-171, 12-172, 12-173, 12-174, 12-175, 12-176, 12-177, 12-178, 12-179, 12-180, 12-181, 12-182, 12-231, 12-232, 12-233, 12-234, 12-235, 12-236, 12-237, 12-238, 12-239, 12-240, 12-241, 12-242, 12-243, 12-271, 12-272, 12-273, 12-274, 12-275, 12-276, 12-277, 12-278, 12-279, 12-280, 12-281, 12-282, 12-283, 12-291, 12-292, 12-293, 12-294, and 12-295.

Section 2. Severability.

It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

Section 3. Inclusion in the Code.

It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, any section or subsection of this Ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section, "article", or other appropriate designation.

Section 4. Effective date.


This ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of Florida that this ordinance has been filed with said


