- "Meeting Topic" - staff report providing the background on the issue. This is broken down into several different types of staff reports.
- "Meeting Comment" – a section of the video in which the issue is discussed
- "Minutes" – action only record of the meeting
- "Historical Minutes" – Minutes of meetings prior to October 2008

SEARCH HISTORICAL MINUTES - MINUTES PRIOR TO OCTOBER 2008


The results page for Historical Minutes will show a list of dates because the Historical Minutes are one PDF document that includes all staff reports and attachments.

Note that there is a duplicate agenda item with an "m" extension. The agenda item letter by itself includes the documents that were submitted to the Board as part of their packet prior to the meeting and the agenda item letter with the "m" extension includes documents that needed to be executed by the Board, such as an agreement or a Resolution. So clicking on "C2-m" takes you to the executed Resolution.
