AN **ORDINANCE PROVIDING FOR** INTENT AMENDING THE **BOUNDARIES** OF THE HOLLAND **SPRING MULTIPURPOSE** MUNICIPAL **SERVICES** BENEFIT UNIT SO AS TO EXCLUDE THEREFROM PORTIONS OF THE PRISTINE PLACE SUBDIVISION WHICH WERE INCLUDED IN A SEPARATE MUNICIPAL **SERVICES** BENEFIT FOR UNIT: **PROVIDING** SEVERABILITY AND INCLUSION IN THE CODE; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION 1. Intent.

It is the intent of the Hernando County Board of County Commissioners to amend the boundaries of the Holland Spring Multipurpose Municipal Services Benefit Unit so as to clarify that land included in the Pristine Place Phase 6 Municipal Services Benefit Unit, as created by Ordinance No. 2006-20, will not be assessed twice for street lighting or other municipal services.

SECTION 2. Amendment of boundaries of Holland Spring Multipurpose Municipal Service Benefit Unit.

The boundaries of the Holland Spring Multipurpose Municipal Service Benefit Unit as created by Hernando County Ordinance No. 91-37 are hereby amended so as to exclude therefrom all land within the Pristine Place Phase 6 Municipal Services Benefit Unit, as created by Ordinance No. 2006-20, which excluded land is legally described in Exhibit A, attached to and incorporated herein.

SECTION 3. Severability.

It is declared to be the intent of the board of county commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

SECTION 4. Inclusion in the Code.

It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, any section or subsection of this Ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section, "article", or other appropriate designation.
