BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION 1. Adopting CPAM-11-01 (Hernando County 11-1ESR). CPAM-11-01 (Hernando County 11-1ESR), attached as Exhibit "A" hereto, is hereby approved and adopted and the Hernando County Comprehensive Plan is amended accordingly subject to Section 6 below.

SECTION 2. Execution. The Chairman of the Hernando County Board of County Commissioners is hereby authorized to execute this ordinance.

SECTION 3. Transmittal to State Land Planning Agency and Review Agencies. County staff shall transmit an executed copy of this ordinance to the State Land Planning Agency and Review Agencies within ten (10) days of adoption hereof pursuant to § 163.3184, Fla. Stat.

SECTION 4. Publication. This ordinance shall be published as required by law.

SECTION 5. Severability. It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

SECTION 6. Effective date. This Ordinance shall take effect upon filing with the Florida Secretary of State; however, the adopted amendment (CPAM-11-01) shall take effect, and be considered an amendment to the Hernando County Comprehensive Plan, if the amendment is not timely challenged, 31 days after the State Land Planning Agency notifies the local government that the plan amendment package is complete or as otherwise provided in § 163.3184, Fla. Stat. If timely challenged, this amendment shall become effective on the date the State Land Planning Agency or the Administration Commission enters a final order determining this adopted amendment to be in compliance.




