ORDINANCE NO.: 2014 -1 2 AN ORDINANCE AMENDING THE HERNANDO COUNTY CODE TO 3 PROVIDE FOR THE LEVY, IMPOSITION, AND SETTING OF TWO 4 ADDITIONAL ONE-CENT TOURIST DEVELOPMENT TAXES THROUGHOUT HERNANDO COUNTY PURSUANT TO THE "LOCAL OPTION TOURIST 5 6 DEVELOPMENT ACT," FLA. STAT. § 125.0104; PROVIDING FOR THE 7 INCORPORATION OF RECITALS; PROVIDING FOR THE LEVY OF SAID 8 TAXES; MERGING HERNANDO COUNTY CODE § 27-31.1 INTO § 27-31; 9 DELETING § 27-31.1; PROVIDING FOR SEVERABILITY; PROVIDING FOR 10 INCLUSION IN THE CODE: PROVIDING FOR THE REPEAL OF 11 CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE. WHEREAS, on May 26, 1992, the Board of County Commissioners of Hernando County, 12 13 Florida adopted Ordinance No. 92-06, which imposed a two (2) percent Tourist Development Tax 14 throughout Hernando County, pursuant to Fla. Stat. § 125.0104; and, 15 WHEREAS, on May 19, 1998, the Board adopted Ordinance No. 98-06, which levied an additional one (1) percent [3rd cent] of tourist development tax throughout Hernando County, Florida, 16 17 pursuant to Fla. Stat. § 125.0104(3)(d), and, 18 WHEREAS, the Hernando County Tourist Development Council has recommended to the 19 Board of County Commissioners of Hernando County, Florida, the imposition of two additional one 20 percent increases [4th cent and 5th cent] in the tourist development tax throughout Hernando County

1	pursuant to Fla. Stat. § 125.0104 for a total tax rate of five (5) percent; and
2	WHEREAS, the Board of County Commissioners desires to amend the Hernando County
3	Code to levy, impose and set the two additional one percent (1%) tourist development taxes in order
4	to increase the marketing budget of the Hernando County Office of Tourist Development to promote
5	and advertise tourism; and,
6	WHEREAS, the Board of County Commissioners wishes to simplify its current Tourist
7	Development Tax Ordinance to merge the provisions of § 27-31.1 into § 27-31; and,
8	WHEREAS, the current tourist development tax levied, imposed and set under Fla. Stat. §
9	125.0104 has been in place for more than three (3) years;
10	NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY
11	COMMISSIONERS OF HERNANDO COUNTY:
12	Section 1. Incorporation of Recitals.
13	The foregoing recitals constitute essential findings of fact by the Board of County
14	Commissioners and accordingly are hereby fully incorporated into this Ordinance by reference.
15	Section 2. Amendment and Revision of Hernando County Code Section 27-31.
16	Section 27-31 of the Hernando County Code is hereby amended to read as follows:
17	Levied and imposed.
18	(a) There is hereby levied and imposed and set a tourist development tax
19	throughout Hernando County, Florida, at the rate of two (2) percent of each
20	whole and major fraction of each dollar of the total rental and consideration

charged every person who rents, leases or lets for consideration any living quarters or accommodations in any hotel, apartment hotel, motel, resort motel, apartment, apartment motel, rooming house, mobile home park, recreational vehicle park, or condominium for a term of six (6) months or less. When receipt of consideration is by way of property other than money, the tax shall be levied and imposed on the fair market value of such nonmonetary considerations. Pursuant to Fla. Stat. §125.0104(3)(d), there is hereby levied, imposed, and set an additional one (1) percent [3rd Cent] of each dollar above the tax rate set under subsection (a) of this section throughout Hernando County. Pursuant to F.S. §125.0104(3)(1), there is hereby levied, imposed and set an additional one (1) percent [4th Cent] of each dollar above the tax rate set under subsection (a) of this section throughout Hernando County. Said fourth cent shall be levied and used in order to promote and advertise tourism in the State of Florida and nationally and internationally in a manner consistent with Fla. Stat. § 125.0104(3)(1). The one percent (1%) tax imposed pursuant to this subsection shall not be subject to, and is exempt from, the requirements of Hernando County Code § 27-32. Pursuant to Fla. Stat. § 125.0104(3)(n), there is hereby levied, imposed and set an additional one (1) percent [5th Cent] of each dollar above the tax rate

set under subsection (a) of this section throughout Hernando County. Said 2 fifth cent shall be levied and used in order to promote and advertise tourism 3 in the State of Florida and nationally and internationally in a manner 4 consistent with Fla. Stat. § 125.0104(3)(n). The one percent (1%) tax imposed pursuant to this subsection shall not be subject to, and is exempt 6 from, the requirements of Hernando County Code § 27-32. (b)(e) The tourist development tax shall be in addition to any other tax imposed 8 pursuant to Chapter 212, Florida Statutes, as amended, and in addition to all 9 other taxes, fees, and the considerations for the rental or lease. 10 (e)(f) The tourist development tax shall be charged by the person receiving the consideration for the lease or rental, and it shall be collected by such person from the lessee, tenant, or customer at the time of payment of the consideration for such lease or rental. (d)(g) The person receiving the consideration for such rental or lease shall receive, account for, and remit the tax to the county tax collector at the time and in the manner provided for by future amendment to this article. Section 3. Deletion of Hernando County Code § 27-31.1. As the provisions of Hernando County Code § 27-31.1 have now been incorporated into § 27-31, Hernando County Code § 27-31.1 is hereby deleted.

Section 4. Severability. It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance. Section 5. Inclusion in the Code. It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the section of this Ordinance may be renumbered or re-lettered to accomplish such intention, and that the word "ordinance" may be changed to "section, "article," or other appropriate designation. Section 6. Conflicting Provisions Repealed. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed. Section 7. Provision of Certified Copy by Clerk to Department of Revenue. A certified copy of this Ordinance shall be furnished by the Clerk of the Court to the Department of Revenue within ten (10) days after approval of such ordinance. Effective Date. Section 8. This ordinance shall take effect immediately upon receipt of official acknowledgment from

the office of the Secretary of State of Florida that this ordinance has been filed with said office. The
