11	WHEREAS, in 1985, the Florida Legislature adopted the Local Government

4 SECTION 4. Transmittal to Florida Department of Economic Opportunity (DEO). The 5 County shall transmit an executed copy of this ordinance to the State Land Planning Agency according to the Guidelines contained on the DEO website. 6 7

8 SECTION 5. Severability. It is declared to be the intent of the Board of County 9 Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this 10 ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance. 11


13 SECTION 6. Effective date. This Ordinance shall take effect upon filing with the 14 Florida Secretary of State; however, pursuant to § 163.3187(5)(c), Florida Statutes, CPAM-15-02 shall not become effective until 31 days after adoption by the BOCC (the date below), unless 15 challenged within 30 days from the date hereof. In the event of any timely challenge, CPAM-15-16 17 02 shall not become effective until the state land planning agency (DEO) or the Administration Commission, respectively, issues a final order determining that this adopted small scale 18 19 development amendment is in compliance.






Future Land Use Map
