Amendment of Carnes Area Road Paving MSBU. Hernando County Ordinance 11 2016-19, "Carnes Area Road Paving Municipal Service Benefit Unit," is hereby amended to add a 12 subpart E to Section IV, "ADMINISTRATION," to read as follows: 13 E.
