8	WHEREAS, on December 22, 1992, the Board of County Commissioners ("the Board"), by
9	enacting Ordinance 92-24, created the Southwest Hernando County Solid Waste Collection
10	Municipal Services Benefit Unit ("the MSBU"); and,
11	WHEREAS, the MSBU allows the Board to levy special assessments to recover the cost of
12	providing garbage collection services to properties in the "Universal Collection Area"; and,
13	WHEREAS, the Board expanded the Universal Collection Area's size in 2013, but did not
14	correspondingly amend the MSBU's boundaries;
15	NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY

17	Section 1. Amending the MSBU's Boundaries. The legal description that is incorporated

3	Section 2. Severability. It is declared to be the intent of the Board of County
4	Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this
5	ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the
6	validity of the remaining portions of this ordinance.
7	Section 3. Conflicting Provisions Repealed. All ordinances or parts of ordinances in
8	conflict with the provisions of this ordinance are hereby repealed.
9	Section 4. Effective Date. This ordinance shall take effect immediately upon receipt of
10	official acknowledgment from the office of the Secretary of State of Florida that this ordinance has
11	been filed with said office.
