ORDINANCE NO.: 2018-10

AN ORDINANCE REPEALING ARTICLE IV OF CHAPTER FIVE OF THE HERNANDO COUNTY CODE, BINGO; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 27, 1993, the Board of County Commissioners enacted Ordinance 93-18, codified as Article IV of Hernando County Code Ch. 5, regulating bingo games; and,

WHEREAS, Fla. Stat. § 849.0931 preempts the regulatory scope of Ordinance 93-18.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY:

Section 1. Repeal of Bingo Ordinance.

Hernando County Code §§ 5-71 through 5-101 are hereby repealed.

Section 2. Severability. It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

Section 3. Inclusion in the Code. It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the section of this ordinance may be renumbered or relettered to accomplish such intention, and that the word “ordinance” may be changed to “section,” “article,” or to another appropriate designation.

1 **Section 4. Conflicting Provisions Repealed.** All ordinances or parts of ordinances in
2 conflict with the provisions of this ordinance are hereby repealed.

3 **Section 5. Effective Date.** This ordinance shall take effect immediately upon receipt of
4 official acknowledgment from the office of the Secretary of State of Florida that this ordinance has
5 been filed with said office.

6 **BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF**
7 **HERNANDO COUNTY** in Regular Session this 22nd day of May 2018.
