2	AN ORDINANCE MODIFYING THE LANGUAGE IN CHAPTER 26, ARTICLE
3	V OF THE HERNANDO COUNTY CODE OF ORDINANCES RELATED TO
4	THE FORM LANGUAGE FOR DEDICATIONS IN PLATS; PROVIDING FOR
5	SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING

8	WHEREAS, Chapter 26, Article V, Section 26-91 of the Hernando County Code of
9	Ordinances sets forth the form language required for the dedications contained within platted
10	subdivisions in Hernando County; and
11	WHEREAS, the form language in dedications contained within platted subdivisions in
12	Hernando County states that utility easements in the plats are granted to Hernando County and public
13	service providers for "ground level, aboveground, and below ground installations, maintenance, and
14	operation of said utilities and service including drainage"; and
15	WHEREAS, it is intended to add express language concerning "construction" of utilities in
16	addition to "operation and maintenance" to the form for dedications contained within platted
17	subdivisions in Hernando County so that the ordinance is clear regarding the ability of Hernando
18	County and public service providers to repair, replace, or add new connections to existing Hernando
19	County utility facilities in all platted subdivisions.
