

ORDINANCE NO. 2004- 15

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF HERNANDO, STATE OF FLORIDA, AMENDING CHAPTER 12, SECTION 12-117(h), HERNANDO COUNTY CODE OF ORDINANCES, TO ALLOW THE BOARD OF COUNTY COMMISSIONERS TO SELECT A MEMBER TO FILL A VACANCY ON THE SPRING HILL FIRE RESCUE DISTRICT COMMISSION WHEN NO CANDIDATE HAS QUALIFIED FOR PLACEMENT ON A REGULAR BALLOT; PROVIDING FOR ENACTMENT AUTHORITY;AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

Section 1. Enactment Authority.

This ordinance is adopted in accordance with and pursuant to the authority of Chapter 125 of the Florida Statutes.

Section 2. Amending Section 12-117(h).

Section 12-117(h) is hereby amended to read:

(h) The board of county commissioners shall have the power to remove a member of the commission for nonfeasance, misfeasance, malfeasance or change of residence from within the district. Vacancies created by the resignation, death or removal from such board of commissioners shall be filled by the board of county commissioners to fill the balance of the term of office of such member. In the event that there is no qualified candidate for a commission seat, then the Board shall appoint a member to fill the seat until the next regularly scheduled commission election.
