2 AN ORDINANCE OF THE HERNANDO COUNTY BOARD OF COUNTY
3 COMMISSIONERS AMENDING CHAPTER 12, ARTICLE 4, DIVISION 2
4 OF THE HERNANDO COUNTY CODE; AMENDING THE DESCRIPTION
5 OF THE HERNANDO BEACH MUNICIPAL FIRE SERVICE UNIT;
6 PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN
7 THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING
8 PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

9 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO
10 COUNTY:

11 **Section 1. Amending the Geographical Description of the Unit.** The geographical
12 description of the Hernando Beach County Municipal Fire Services Unit, as contained in Exhibit "A"
13 to Hernando County Code Ch. 12, Article 4, Division 2, is hereby amended to read as follows:

14 HERNANDO BEACH VOLUNTEER FIRE DISTRICT

15 MSBU LEGAL DESCRIPTION

16 Sections 11, 12, 13, 14, and 24, plus the North ½ of Section 25, less the South ½ of
17 the West ½ thereof, all of Township 23 South, Range 16 East; plus that part of
18 Section 7, Township 23 South, Range 17 East, lying West of Hernando Beach Road
19 (595-C).

20 -and-

1 All parcels in Township 23 South, Range 16 East, Sections 23, 24, 25, 26, 35, and
2 36.

3 -and-

4 Section 7 East of Shoal Line Boulevard, All of Section 8, the West ½ of Section 9,
5 Sections 17-19, and the North ½ and Southwest ¼ of Section 30, all contained in
6 Township 23 South, Range 17 East.

7 **Section 2. Severability.** It is declared to be the intent of the Board of County
8 Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this
9 ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the
10 validity of the remaining portions of this ordinance.

11 **Section 3. Inclusion in the Code.** It is the intention of the Board of County Commissioners
12 of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall
13 become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the
14 section of this Ordinance may be renumbered or re-lettered to accomplish such intention, and that
15 the word “ordinance” may be changed to “section,” “article,” or other appropriate designation.


16 **Section 4. Conflicting Provisions Repealed.** All ordinances or parts of ordinances in
17 conflict with the provisions of this ordinance are hereby repealed.

18 **Section 5. Effective Date.** This ordinance shall take effect immediately upon receipt of
19 official acknowledgment from the office of the Secretary of State of Florida that this ordinance has
20 been filed with said office.
