ORDINANCE NO.: 2017-8

AN ORDINANCE PROVIDING FOR THE SUNSET OF THE HERNANDO BEACH MUNICIPAL FIRE SERVICE UNIT; AMENDING THE GEOGRAPHIC BOUNDARIES OF THE HERNANDO COUNTY FIRE RESCUE MUNICIPAL SERVICES TAXING UNIT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY:

Section 1. Sunset of the Hernando Beach Municipal Fire Service Unit. The Hernando Beach Municipal Fire Service Unit, and the ordinances governing said taxing district, Hernando County Code §§ Sec. 12-76 - 12-90.2, inclusive, are hereby repealed.

Section 2. Amendment of the Geographic Boundaries of the Hernando County Fire Rescue Municipal Services Taxing Unit. Hernando County Code § 12-312 is hereby amended to read as follows:

Creation and boundaries of unit.

The Hernando County Emergency Fire Rescue and Suppression Services Municipal Service Taxing Unit ("the Unit") is hereby created for the purpose of funding the operations of an emergency fire rescue and suppression services system ~~within the~~

1 ~~area described in exhibit "B" attached hereto and incorporated herein~~ within all of
2 ~~the unincorporated area of Hernando County, Florida, as described in Section 7.27,~~
3 Florida Statutes. ~~The unit may be described by a legal description or a map. Where~~
4 ~~there is a conflict or discrepancy between the map and the legal description, the legal~~
5 ~~description shall prevail.~~

6 **Section 3. Severability.** It is declared to be the intent of the Board of County
7 Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this
8 ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect
9 the validity of the remaining portions of this ordinance.

10 **Section 4. Inclusion in the Code.** It is the intention of the Board of County Commissioners
11 of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall
12 become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end,
13 the section of this Ordinance may be renumbered or relettered to accomplish such intention, and that
14 the word "ordinance" may be changed to "section," "article," or other appropriate designation.

15 **Section 5. Conflicting Provisions Repealed.** All ordinances or parts of ordinances in
16 conflict with the provisions of this ordinance are hereby repealed.

17 **Section 6. Effective Date.** Except as provided for in Section 1 above, this ordinance shall
18 take effect immediately upon receipt of official acknowledgment from the office of the Secretary
19 of State of Florida that this ordinance has been filed with said office.
