Hernando County Code, is hereby amended as follows:

Sec. 8-97. - Adoption of the Florida Building Code Seventh Edition (2020), as promulgated by the Florida Building Commission.

There is hereby adopted by the County of Hernando, Florida, that certain statewide unified code known as the Florida Building Code, as developed and maintained by the Florida Building Commission and amended from time to time, being particularly the Florida Building Code Seventh Edition (2020). The same, as it may be amended from time to time, is hereby adopted and incorporated herein as fully as if set forth in haec verba, and from the date upon which this division shall take effect, the provisions thereof, except as otherwise noted herein, shall be controlling in the construction, alteration, removal, demolition, moving, improving, repairing of equipment, use and occupancy, location and maintenance of all buildings and structures within the unincorporated areas of the county. Upon the effective date of the Florida Building Commission's adoption of the Florida Building Code and each subsequent amendment of the Florida Building Code, that most recent edition of the Florida Building shall be incorporated by reference as if fully set forth herein. The automatic adoption of the most recent edition of the Florida Building Code shall be subject to any technical amendments or procedures Hernando County may implement in this code.

Section 2. Severability. It is declared to be the intent of the Board of County
