ORDINANCE NO.: 2023 - 06

AN ORDINANCE MERGING THE HOLLAND SPRINGS MULTI-PURPOSE, THE BARONY WOODS EAST STREET LIGHTING, AND THE HOLLAND SPRING INDUSTRIAL PARK STREET LIGHTING MUNICIPAL SERVICES BENEFIT UNITS INTO THE WEST HERNANDO STREET LIGHTING MUNICIPAL SERVICES BENEFIT UNIT; PROVIDING FOR THE INCORPORATION OF RECITALS; REPEALING TO-BE-MERGED MUNICIPAL SERVICES BENEFIT UNITS; AMENDING THE LEGAL DESCRIPTION OF THE WEST HERNANDO STREET LIGHTING MUNICIPAL SERVICES BENEFIT UNIT; PROVIDING FOR THE TRANSFER/REFUND OF REMAINING FUNDS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a recent analysis performed by the Department of Public Works has revealed that due to rising operational costs and the depletion of reserves, the amount of the annual assessments to be levied by the Holland Springs Multi-Purpose, the Barony Woods East Street Lighting, and the Holland Spring Industrial Park Street Lighting Municipal Services Benefit Units (“MSBU’s) will have to increase sharply in the near future; and,

WHEREAS, the Department of Public Works’ analysis found the best way to limit the future assessment increases on the parcels within the above-referenced MSBU’s is to merge those small MSBU’s into the much larger West Hernando Street Lighting MSBU.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY:

Section 1. Incorporation of Recitals. The foregoing recitations are hereby incorporated by reference as if fully set forth herein.

1 **Section 2. Repeal of the To-Be Merged MSBU’s.** Hernando County Code §§ 24-421
 2 through 24-427 (creating the Holland Springs Multi-Purpose MSBU), 24-536 through 24-540
 3 (creating the Barony Woods East Street Lighting MSBU), and 24-2045 through 24-2049 (creating
 4 the Holland Spring Industrial Park Street Lighting MSBU) are hereby repealed.

5 **Section 3. Amending the West Hernando Street Lighting MSBU's Boundaries.** The
 6 legal description that is incorporated into Ordinance No. 2013-42, as Exhibit “A” thereto, is hereby
 7 amended to read as follows:

30 Holland Springs Multi-Purpose, the Barony Woods East Street Lighting, and the Holland Spring
31 Industrial Park Street Lighting MSBU's, if any, shall be transferred to their successor-in-interest, the
32 West Hernando Street Lighting MSBU; provided, that funds collected by the repealed MSBU's from
33 parcels that are not included within the West Hernando Street Lighting MSBU, as it boundaries are

1 amended by this ordinance, shall be refunded to the current owners of those parcels on a pro rata
2 basis.

3 **Section 5. Severability.** It is declared to be the intent of the Board of County
4 Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this
5 ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the
6 validity of the remaining portions of this ordinance.

7 **Section 6. Inclusion in the Code.** It is the intention of the Board of County Commissioners
8 of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall
9 become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the
10 sections of this Ordinance may be renumbered or relettered to accomplish such intention, and that
11 the word “ordinance” may be changed to “section,” “article,” or any other appropriate designation.

12 **Section 7. Conflicting Provisions Repealed.** All ordinances or parts of ordinances in
13 conflict with the provisions of this ordinance are hereby repealed.

14 **Section 8. Effective Date.** This ordinance shall take effect immediately upon receipt of
15 official acknowledgment from the office of the Secretary of State of Florida that this ordinance has
16 been filed with said office.
